Affidavit & Technical specifications submitted through online in Envelope “B”. Financial Bid-Envelope “c” have to be submitted through online e-tender process only.

The tenders shall be accepted online on or before 30-03-2016 at 12.01 PM. as per the Key Dates, The tender will be opened online and authorised representatives of bidders may choose to be present during the opening or may view online. In case the dates mentioned above happen to be a Public Holidays, the next working day will be reckoned for the purpose.

Tender for Kanta batt set shall be accepted from the licensed manufactures, or their authorize dealers. The parties shall offer the material strictly conforming to the specifications, terms and conditions of the tender enquiry. The tenders not conforming strictly to specifications, other terms & conditions of the tender enquiry, incomplete and conditional tenders will be summarily rejected. Further in order to assess manufacturing facilities available with the tenderers, the inspection facilities may be required to be arranged by the party at the discretion of the Corporation.

Post Purchase Inspection has to be conducted at the receiving end by the concerned staff of C.G. State Warehousing Corporation and the same will be endorsed in receipt certificate. The payment to the supplier will be released only after the confirmation of receipt of consignment in good condition.
