The tenders are to be submitted in three parts. **EMD / Notary attested NSIC certificate** with **affidavit** submitted physically, **Bid-A** (Technical specifications) and **Bid-C** (financial offer).

Technical Bid-A & Financial Bid-C have to be submitted through online e-tender process only.

The tenders shall be accepted **on 22.02.2014 at 17.00 PM.** as per the Key Dates., in the presence of Tenderers, who may wish to be present at their own cost or they can view through online website. In case the dates mentioned above happened to be a public Holiday, the next working day will be reckoned for the purpose.

Kanta Batt set shall be accepted from the licensed manufactures, and their authorize dealers.
